The events will be part of the PIRS skated on the 200 M bank track and on the 500 and 800 M road track. Ranking points will be issued for both bank track and road races. There will be an individual 300 M and 200 M Time Trial for all Age Categories. 300 M Time trial events will begin at 9 am, Saturday, Jan. 15 at Brian Piccolo Park.

Track and Road divisions will have 3 races for elite division and 2 races for novice division on the bank and track courses. Skaters can register for one or all races and an overall will be awarded to those skaters skating all 6 races. Time trials will be by age only and separate cash awards will be given.
